In exchange for Releasor's participation and consent to equine or rodeo related activities by Releasor on Releasee's real property, Releasor releases, waives and discharges Releasee, Releasee's agents, employees or guests and each of them for any and all loss or damage, and any claim or damages resulting therefrom, on account of injury to Releasor's person or property, even injury resulting in death of Releasor caused by Releasee's negligence or otherwise, while Releasor is located on Releasee's real property, including riding, saddling or other rodeo related activities. Montana Code Annotated § 27-1-727 and 733.

Releasor agrees to indemnify Releasee from any loss, liability, damage or cost Releasee may incur due to the presence of Releasor's horses in or upon the arena and parking area of Releasee, whether caused by the negligence of Releasee.

Releasor hereby assumes full responsibility for risk of injury, death or damage to Releasor's horses due to the negligence of Releasee while in or upon the real property or while participating for any purpose in horsemanship, equine activities, or rodeo related activities.

Releasor expressly agrees that this release, waiver and indemnity is intended to be as broad and inclusive as permitted by the laws of the state of Montana, and if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect.
